Organised under the auspices of the International Peat Society (IPS) this leading international conference will adopt an entirely new approach to the peat debate. Through an **innovative conference structure** Tullamore 2015 will ensure that issues will be thoroughly discussed and debated. From Wise Use to responsible use, from sustainability to eco-system services the many and varied perspectives and viewpoints will be asked to come together to have a real conversation about the way forward.

To open the event we will have two distinguished Keynote Speakers - Marcel Silvius of Wetlands International, and Marian Harkin MEP. Both are familiar with the importance and scale of the issues relating to peatland management - at the local and international impact levels. This will be followed by a lively and **Interactive Poster Session** where we will bring the posters out of the shadow and highlight their valuable contribution. After that we will break from

Second Workshop: Fens after Drainage - Landscape and Soil

IPS Commission III Agricultural use of peatlands and peat is organizing an international workshop "Fen peatlands after drainage – landscape and soil" on between 6 - 10 July 2015 in Olsztyn, NE Poland. The workshop will take place at the most beautiful campus in Poland – the University of Warmia and Mazury in Olsztyn. The workshop will be devoted to the problems of organic soil classification, role of peatlands in the landscape, agricultural use of peatlands as well as restoration and protection of these wonderful areas. The workshop will be divided into discussion panels (oral session) and field trips (field session). The field session will take place at peatlands developed on gyttjas (lacustrine deposits) and parts of restored peatlands. For more information, contact barbara.kalisz (at) uwm.edu.pl.

EPAGMA and CSPMA Sign Memorandum of Agreement

In January 2015 the European Peat and Growing Media Association (EPAGMA) and Canadian Sphagnum Peat Moss Association (CSPMA) signed a Memorandum of Agreement (MOA) which established a working relationship to ensure the continued health and function of peatland systems; and the promotion of responsible resource-based industry practices at the national member state and international levels. Pat Fitzgerald; Chairman of EPAGMA Executive Board stated "That since both agencies share core values including innovative and ethical management practices, respect for people and cultural traditions and ecosystem-based responsible development it was considered important that we work together to advance these interests." Challenges to the responsible management of peatland resources and development of the peat industry are both local as well as global in their reach. According to Paul Short, President of the CSPMA "It is essential that policies that impact the peatland resource and industry are developed based on sound science, social acceptance and responsible management. A joint approach is important to ensuring unified understanding of issues and successful outcomes to common concerns." The MOA will be in effect for 5 years. During this time specific joint research projects, operational trials and best resource and management practices will be identified in order to address policies, regulations and directives arising from International Conventions and

Agreements or Canadian, US and European Union legislation. EPAGMA will take leadership in addressing these elements within the European Union, the CSPMA will take leadership on other relevant International Conventions and Agreements as well as US and Canadian policies.

National Award for Abbyleix Bog Project

The Abbeyleix Bog Project has won a joint-third prize in the Get Involved Awards, which promote voluntary sustainability initiatives throughout Ireland. The project was one of 22 entries from 18 counties. They were presented with a € 500 bursary and a special award certificate. The Get Involved Awards is the focal point for the Get Involved project, a sustainable community initiative and competition established by two local newspaper associations, NNI Local and Local Ireland. The third place was shared between the Abbeyleix Bog Project and Transition Kerry. Following negotiations with Bord na Móna, a lease was signed in 2010 that handed over the bog to the local community to manage for a period of 50 years, with a primary focus on conservation. The project is using a community-based Natural Resource Management approach, a Conservation Management Plan and Business Management Plan, to maximise the ecological benefits to the local community in terms of education, employment, income and recreation. Registration for Ramsar COP12 in Uruguay

The Ramsar Secretariat announces that the preregistration process is now open for the 12th Meeting of the Conference of the Contracting Parties, to be held at the Conrad Hotel, Punta del Este, Uruguay from 1 to 9 June 2015. The preregistration process will close on 15 May. Access to online preregistration and other practical information about COP12 are available on the Ramsar Convention web site at: www.ramsar.org/about/cop12-punta-del-este-uruguay-1-9-june-2015. In addition to official delegations from the Contracting Parties, eligibility to participate in the COP as observers is extended to delegations from the governments of non-Party states and to representatives of inter-governmental organizations, recognized non-governmental organizations working in the field of wetland conservation and sustainable use, and government agencies which are not part of their country's official delegation.

New Guide: Life and Climate Change Mitigation

The latest LIFE Environment Focus publication takes an in-depth look at LIFE's work till now in support of climate change mitigation. The 88-page brochure gives an overview of EU climate policy and provides a host of best practice examples from more than 200 featured projects from across the European Union. It contains interviews with representatives of DG Climate Action and with NGOs active in the field, highlighing the climate mitigation challenges ahead and LIFE's role in the transition to low-carbon agriculture. The LIFE climate change mitigation project examples are divided by theme, with e.g. chapters on agriculture and forestry; the role of peatlands and wetlands as carbon sinks; and projects involving enterprises.
